Since his retirement from active-duty in 2014, Commander Ken Shook. JAGC, USN (ret) has worked as a financial advisor with First Command Financial Services and currently leads a team of eight advisors in Chesapeake, Virginia.

In 1997, Ken resigned his active duty commission, joined the Naval Air Reserves' TACTICAL CONTROL SQUADRON 2186 at NAB Little Creek, Norfolk, Virginia and matriculated law school. In 2000 he earned his Juris Doctor degree from the College of William and Mary Law School and was admitted to the Virginia State Bar. Upon completion of his legal studies, he entered private practice with a law firm but returned to active duty in the Navy's Judge Advocate General's Corps in 2001. In 2010 he earned a Master of Laws degree in National Security and U.S. Foreign Relations Law from the George Washington University School of Law.
